The trade body for consultancy in the UK, the Management Consultancies Association www.mca.org.uk is forecasting an additional 10,000 jobs in the next three years at UK consultancies. Its latest survey https://tinyurl.com/56jb6u6x anticipates activity increasing by 13% in 2023 and 12% in 2024. Key drivers of growth are digital transformation (still!), cost reduction, cybersecurity, sustainability and environmental issues. The digital and technology sectors, energy and resources, and health and life sciences are expected to experience the biggest growth, followed by financial services. 2022 saw growth of 25% (2021 18%), and the MCA says that the UK is now one of the biggest centres for consulting in the world. Commenting on the MCA report, website www.consultancy.uk adds that more than half of the new roles will be based outside London in regional centres such as Birmingham, Manchester, Glasgow and Edinburgh. Growth plans for the Big Four include a doubling of EY to 10,000 consultants by 2026, and 1,500 new hires for Deloitte in 2023. Smaller firms are predicting an additional 4,000 joiners by 2024.
